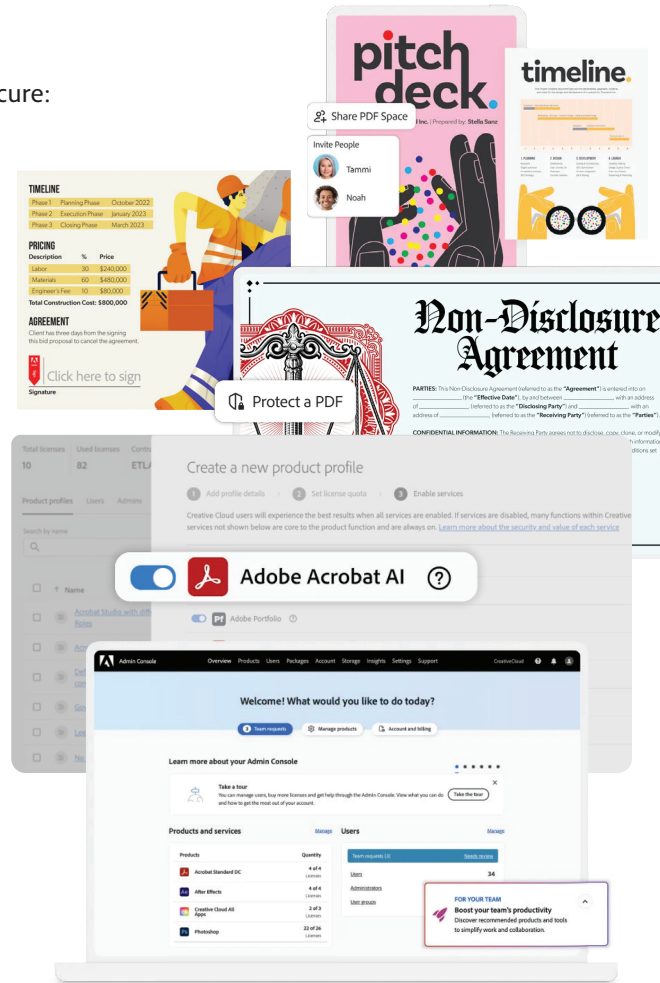

- **Responsible AI**
 - Adobe doesn't use customer data to train our LLMs, generative AI in Acrobat Studio only processes the documents you choose, and you can verify AI insights through citations linking directly to your source documents.
- **Application security**
 - Acrobat offers multiple layers of protection, including sandboxing with Protected Mode and Protected View, to stop threats before they reach your documents or systems. No other PDF solution offers comparable enterprise-grade protection.
- **Information protection**
 - Safeguard sensitive information and enforce consistent data policies through encryption, password controls, redact and seal capabilities, and integration with Microsoft Purview.
- **Centralized management**
 - Build a strong security perimeter through centralized access control, secure trust and identity frameworks, enterprise mobility management, and restrictions on user-driven installs.
- **Core security**
 - Adobe builds security into everything we do. Our security operations organization develops products with strict security standards and provides ongoing threat monitoring, vulnerability management, and incident response to protect your data.
