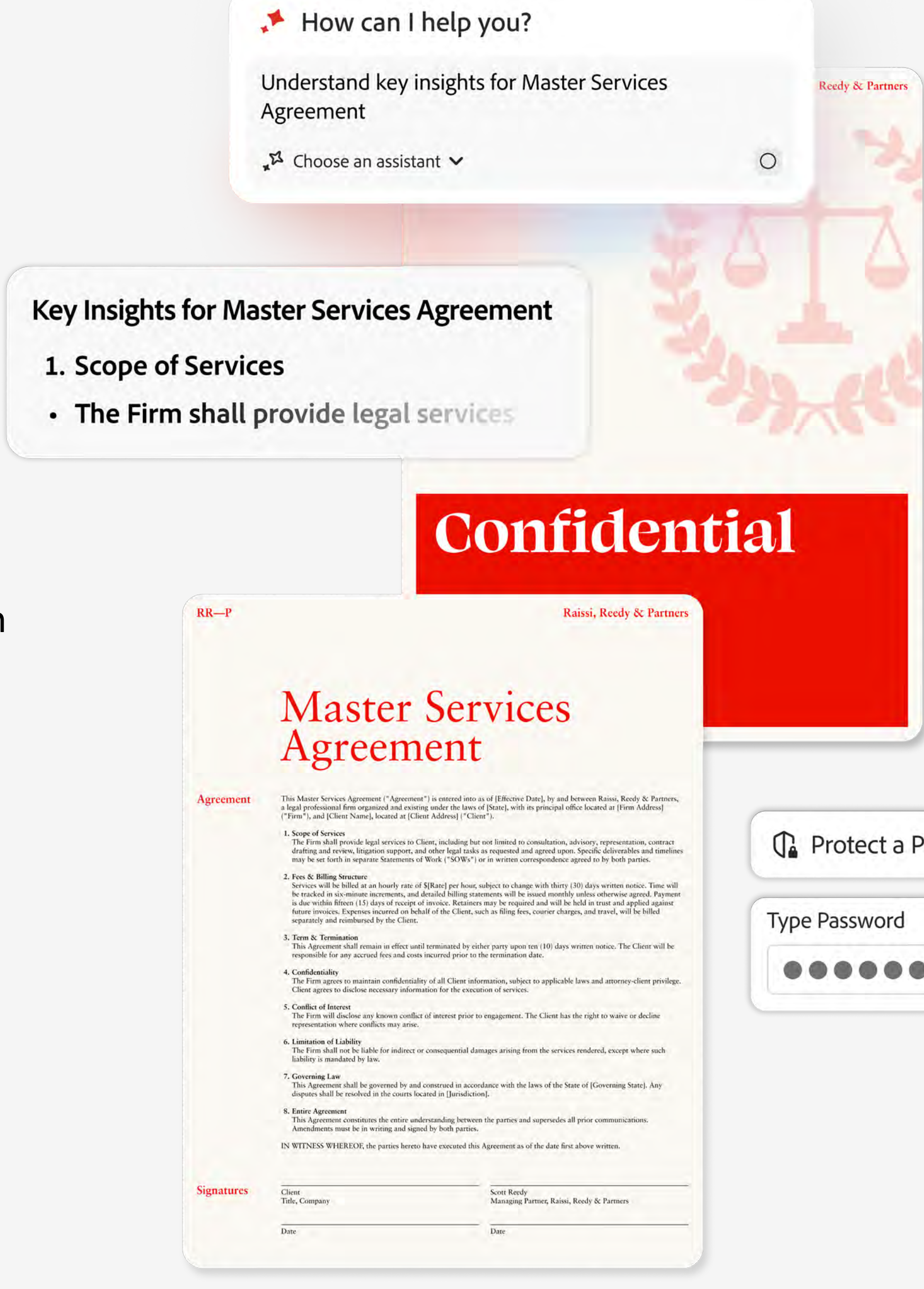

- Create fillable forms, collect e-signatures, and track completion to keep approvals moving.

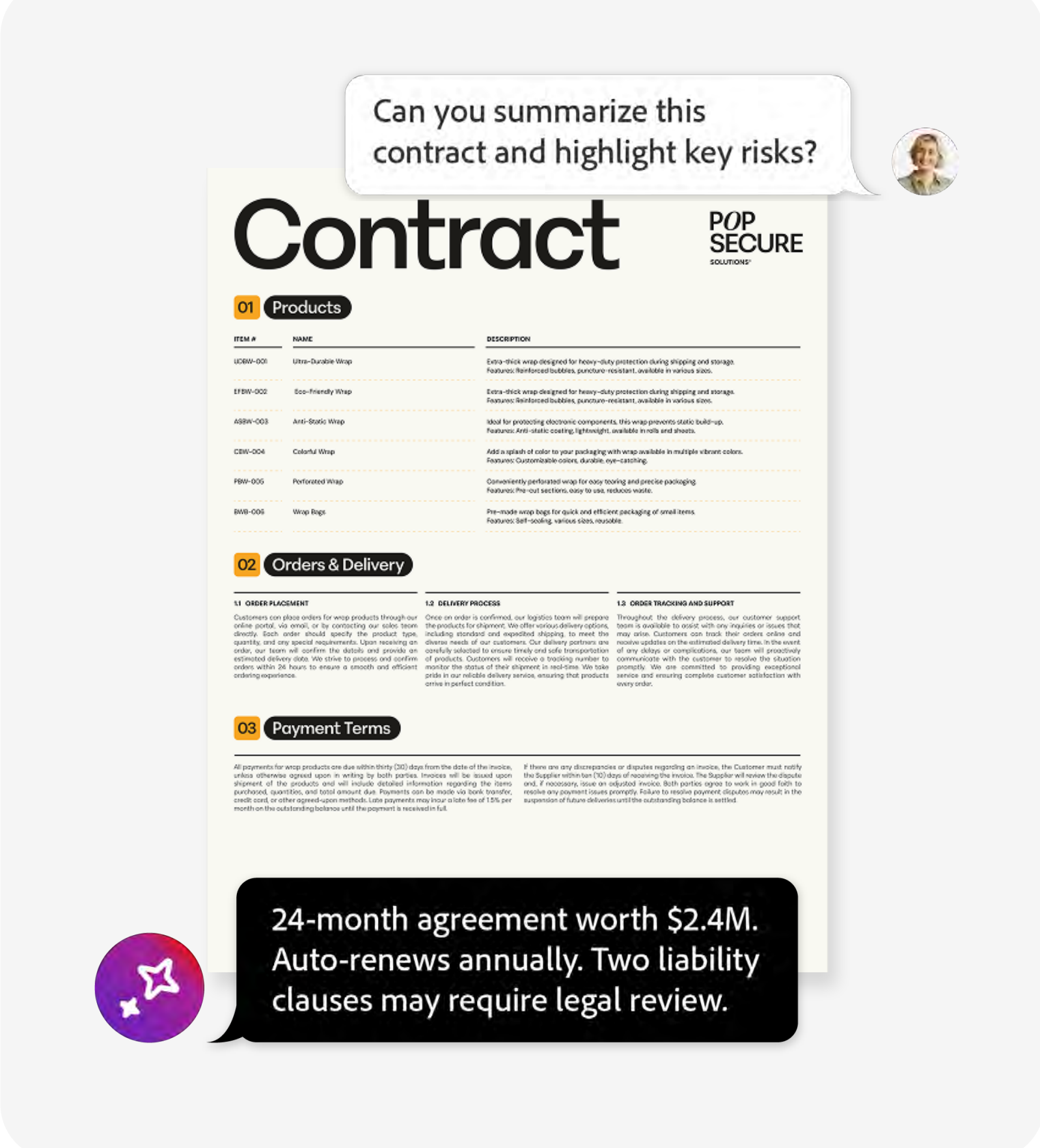

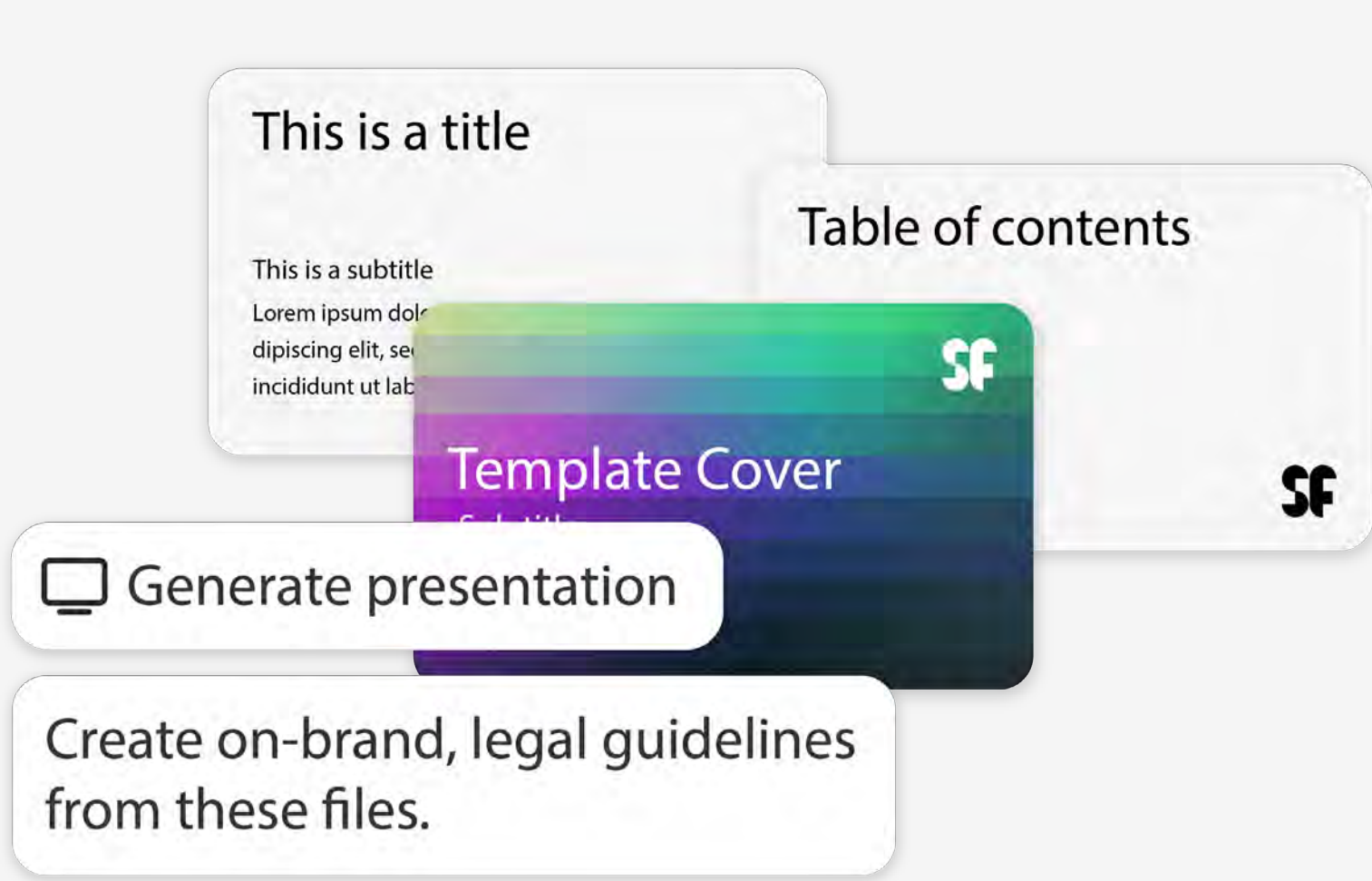


- Comprehend:** Use AI Assistant to analyze and compare vendor information across docs with traceable references for easy fact-checking.

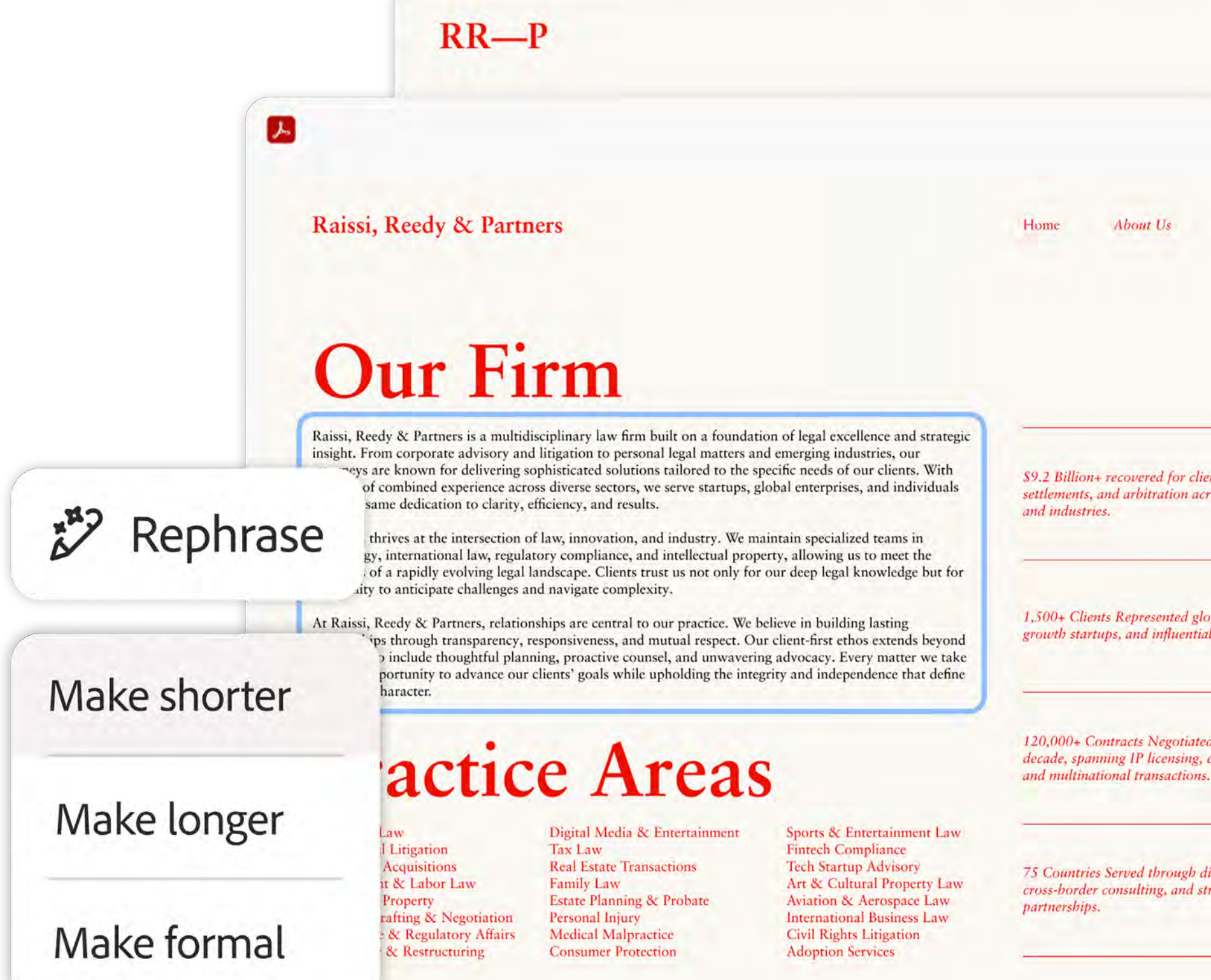
More than half of professionals (57%) cite faster workflows as AI's most significant outcome, followed by reduced manual workload (47%) and fewer errors (43%).
